Change in Number of Issued and Outstanding Shares

Background/Description of the Disclosure

The change in the number of issued and outstanding shares of Steniel Manufacturing Corporation (the "Company") was due to the issuance of 418,812,081 shares upon approval by the Securities and Exchange Commission ("SEC") of the Company's application for increase of authorized capital stock from P1 Billion to P2 Billion on December 29, 2020, as disclosed by the Company. These shares were subscribed partly through debt to equity conversion and partly through a share swap transaction by the following:

A. Debt to Equity Conversion

1. Greenkraft Corporation - conversion of advances in the amount of P11,469,532 to 11,469,532 STN Shares;
2. Roxburgh Investments Limited – conversion of advances in the amount of P138,092,549 to 138,092,549 STN Shares.

B. Share Swap Transaction

1. Greenkraft Corporation – assignment of 89,767,950 common shares in Steniel Mindanao Packaging Corporation (SMPC) to the Company in exchange for 89,767,950 STN Shares;
2. Corbox Corporation – assignment of 80,775,000 common shares in SMPC to the Company in exchange for 80,775,000 STN Shares;
3. Golden Bales Corporation – assignment of 80,775,000 common shares in SMPC to the Company in exchange for 80,775,000 STN Shares
4. Rex Chua – assignment of 8,966,025 common shares in SMPC to the Company in exchange for 8,966,025 STN Shares; and
5. Clement Chua – assignment of 8,966,025 common shares in SMPC to the Company in exchange for 8,966,025 STN Shares.

The foregoing 418,812,081 shares were issued on December 29, 2020 upon approval by the SEC of the Company's application for increase of authorized capital stock.
